


## S4D30120H 1200V SIC POWER SCHOTTKY RECTIFIERS




Fig.1-Typical Forward Voltage Characteristics




Fig.2-Typical Reverse Characteristics




Fig.3-Capacitance vs. Reverse Voltage




Fig.4-Current Derating




Fig.5-Power Derating




Fig.6-Total Capacitance Charge vs. Reverse Voltage





Fig.7-Capacitance Stored Energy

**Marking Diagram**


