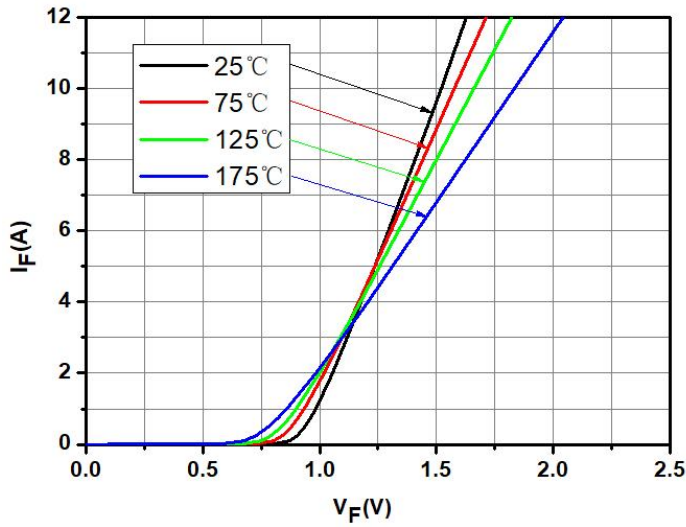


Fig.1-Typical Forward Voltage

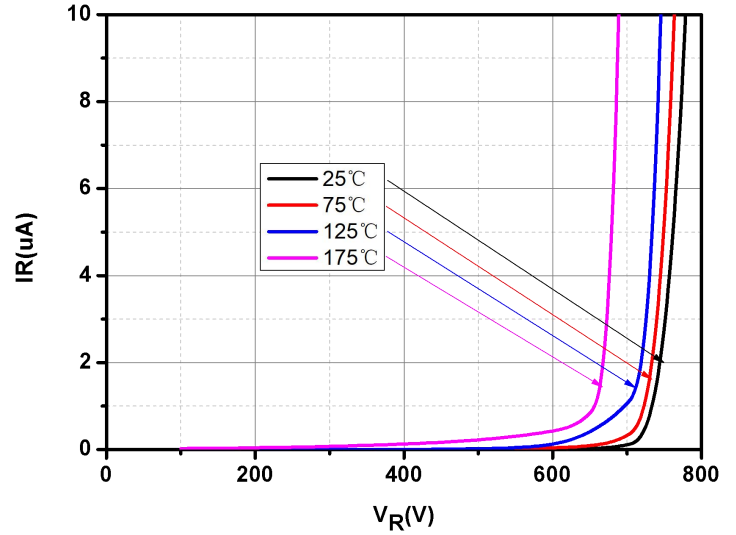


Fig.2-Typical Reverse Characteristics

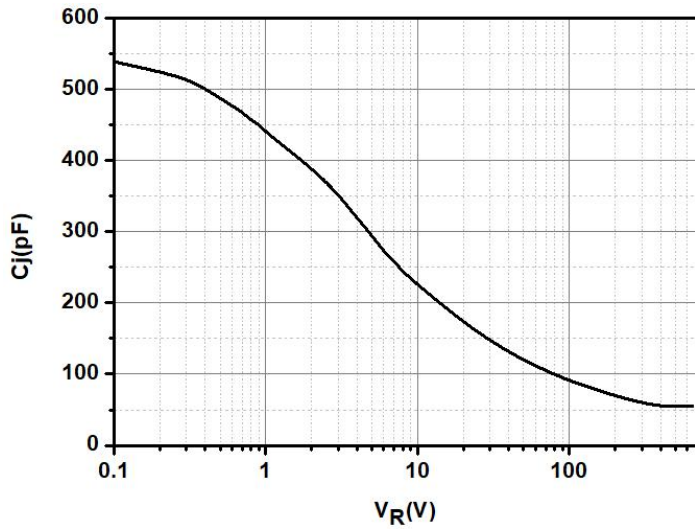


Fig.3-Capacitance vs. Reverse Voltage

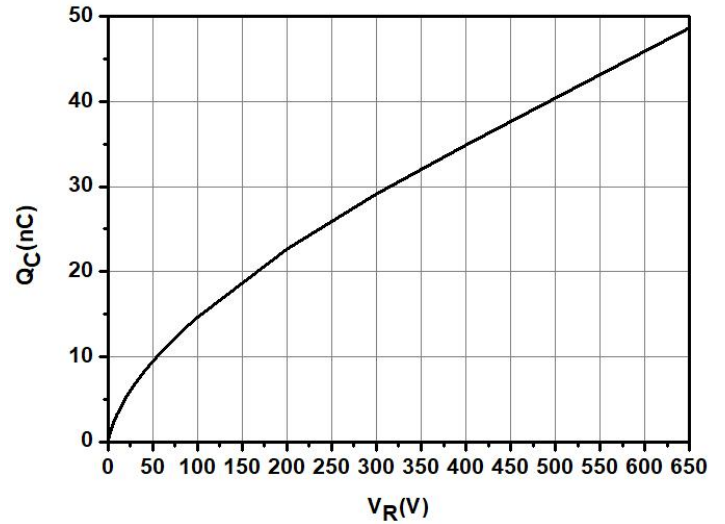


Fig.4-Total Capacitance Charge vs. Reverse Voltage

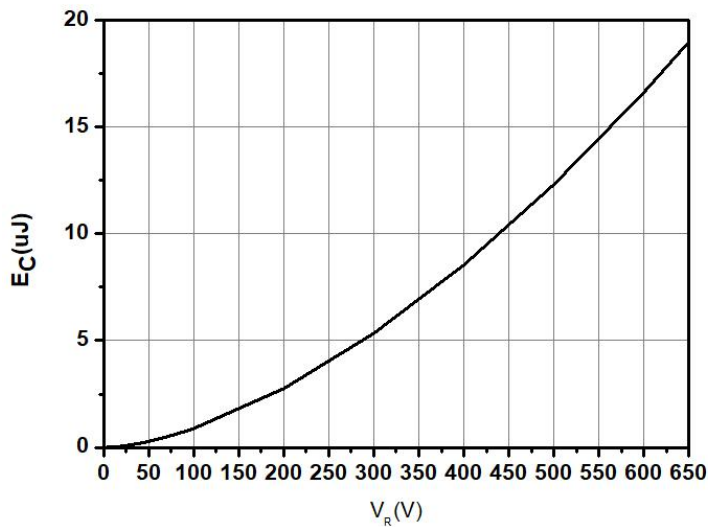


Fig.5-Capacitance Stored Energy

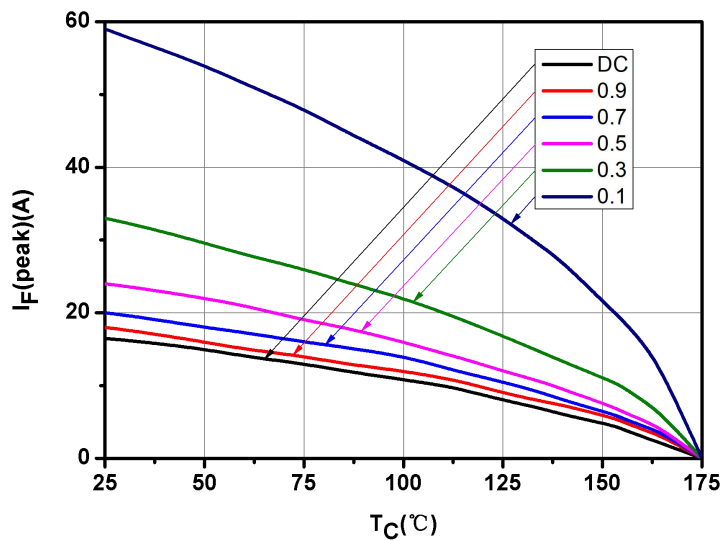


Fig.6-Current Derating

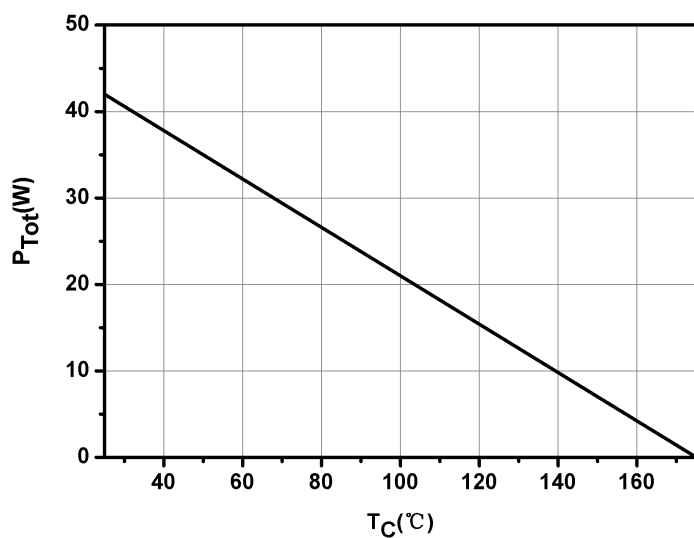
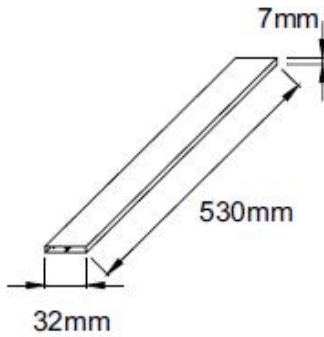


Fig.7-Power Derating

Marking Diagram

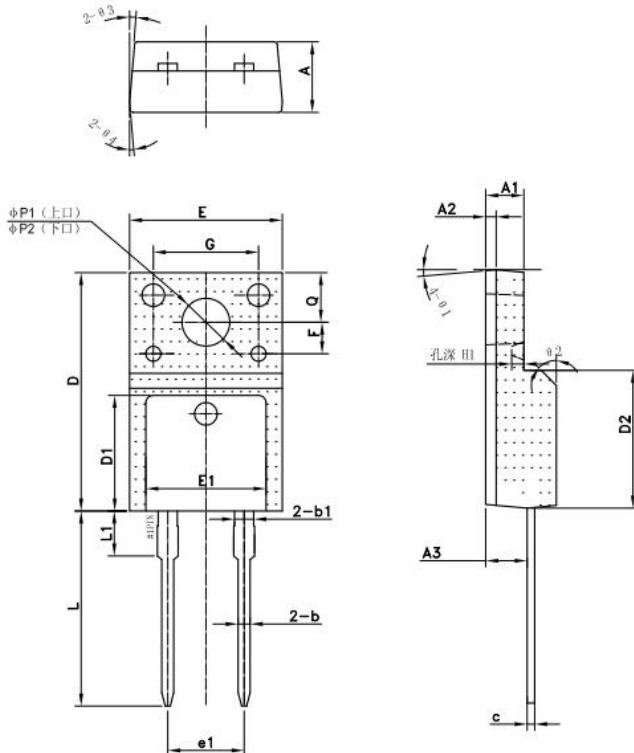
